I am directed to inform you that the Wrestling Federation of India [WFI] is holding a Selection Trial on 10th June 2018 at 10.00 hrs. at STC, Lucknow for selecting the **Indian Senior Women Wrestling Team** for participation in the 2018 Asian Games and 2018 World Championship. There are 6 weight categories to be played in 2018 Asian Games. However, the Federation is holding the trial in 4 weight categories i.e. 53, 57, 68 and 76 Kg. The Selection Committee in consultation with the Chief Coaches has excused the following prominent wrestlers from the trial based on their past performance and selected them for the 2018 Asian Games only. However, these Wrestlers will give trial in their respective weight category for the 2018 World Senior Championship.

1. Vinesh, 50 Kg.
2. Sakshi Malik, 62 Kg.

The selected Wrestlers in above 4 weight categories will represent Country in the forthcoming 2018 Asian Games as well as 2018 World Senior Wrestling Championship. The trial for the rest weight categories to be played in World Championship i.e. 50, 55, 59, 62, 65 & 72 Kg. will be held in the end of June 2018. However, the selected Wrestlers in 50 and 62 Kg. will compete the final trial with Vinesh and Sakshi Malik respectively for the World Championship after the Asian Games.

Navnath Dhamal, Sh. Bijender Singh & Sh. Hari Ram Yadav would be the Referees / Judges for the above Selection Trial.
